It has been kept, used, kept confidential and used as the data subject consented and in accordance with the Personal Information Protection Act 2019, the Company has set up the personal information protection policy as follows

- 1. The company respects the privacy of its customers, business partners, employees and all related parties to the utmost.
- 2. The company will ask for personal information only as necessary to service the job. Or according to the law and will request from direct data subject only.
- 3. The company will notify the purpose of requesting, use, keeping, inform the owner of the information and consent from the beginning.
- 4. The company has set up a system for the using, the processing, and the collection of personal information very tight. To conceal a confidential.
- 5. The company has established a personal data controller, review person and approved person to ensure that personal information is used in accordance with purpose. Do not use beyond your consent. Or does not cause any damage to the owner of the data.
- 6. Information with specific controls, such as information on ethnicity. Political opinion, Beliefs in religion, illness, crime history, religion. If required, the company will ask for the consent of the owner of the information expressly and use it with caution in confidentiality.
 - 7. The data subject, has the right to access, review, and cancel consent of that information at any time.
 - 8. The person who is foreigner will keep and use the information the same as that of Thai people.
 - 9. If personal information is to be sent to an external organization or abroad. The Company will follow the law strictly.
- 10. Personal information that the company keeps, the company will treat as it is the company's own property. It is forbidden to let anyone violate, disclose, access, lead to personal gain. Or destroy this information without the data controller's approval. Violators will be subject to the highest sanctions. Will prosecute to the end including compensation for damages incurred in full according to the legal rate

The company requests all employees involved to comply with this policy and or any operating regulations. That are strictly involved in order to continue this policy to achieve its objectives effectively.
